Summary Annual Report for

This is a summary of the annual report for IBEW LOCAL UNION NO 102 SURETY PLAN, EIN 22-2347484, Plan Number 002, for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust and insurance and/or annuity contracts. Total plan expenses were \$37,267,246. These expenses included \$285,126 in administrative expenses and \$36,982,120 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 3,914 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$636,964,798 as of December 31, 2023, compared to \$592,237,371 as of January 1, 2023. During the plan year the plan experienced a change in its net assets of \$44,727,427. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$81,994,673 which included employer contributions of \$28,861,804, employee contributions of \$0, other contributions of \$200,528, gain/loss of \$0 from the sale of assets, and earnings from investments of \$52,932,341.

The plan has (a) contract(s) with MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY and MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY, which allocates funds toward individual policies. The total premiums paid for the plan year ending December 31, 2023 were \$0.
